1. AQHA Training Level Test of Choice (2019 USEF Training Level Tests 1, 2 or 3)
2. AQHA First Level Test of Choice (2019 USEF First Level Tests 1, 2 or 3)
3. AQHA Second Level and above Test of Choice (2019 USEF Second Level and above)
4. AQHA All-Level Test of Choice (2019 Intro - Grand Prix) *(use this class for your second class of the day if you are entering two AQHA classes of the same level)*
5. All-Breed Training Level Test of Choice (2019 USEF Training Level Tests 1, 2 or 3)
6. All-Breed First Level Test of Choice (2019 USEF First Level Tests 1, 2 or 3)
7. All-Breed Second Level and Above Test of Choice (2019 USEF Second Level and above)
8. All-Breed All Level Traditional Dressage Test of Choice (2019 Intro - Grand Prix) *(use this class for your second class of the day if you are entering two All-Breed classes of the same level)*
9. All-Breed Western Dressage Test of Choice (2017 Tests - All Levels)
10. All-Breed Western Dressage Test of Choice (2017 Tests - All Levels) *(use this class for your second class of the day if you are entering two All-Breed Western Dressage Classes)*

FEES: \$8 Office Fee per horse/per day; \$6 Drug Fee per AQHA horse/per day (All-Breed classes do not pay Drug Fee); \$15 grounds fee (if not stabled); \$12 class entry fee; \$13 dressage arena fee per class (not included in AQHA Show flat fee); \$5 per test Post Entry fee for those entering after 4pm Friday

STABLING & CAMPING: \$100 per stall (includes 3 bags shavings); \$8 additional shavings (NO OUTSIDE SHAVINGS ALLOWED)
RV Hook-ups \$35/night: **Contact: Susan Daniels 919-894-0600 for stall & RV reservations**

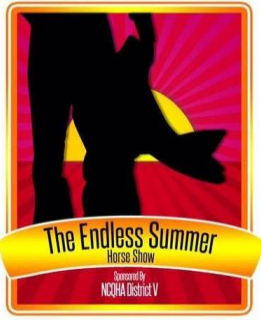
COGGINS: Copy of current negative coggins (12 months) must be posted on stall door, or in your vehicle (day parking)

TIMES: Request time frame around your other classes. (8-10am, 10am-12pm, 12-2pm) Pre Entries will receive times by 5pm Friday

TACK and ATTIRE: USEF rules apply. Jackets are waived (not required) for the entire competition.
